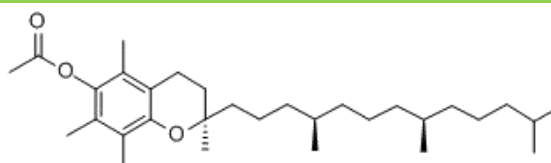

Description

Vitamin E acetate, also called tocopherol acetate, is a dry form of vitamin E that is commonly referred to as tocopherols. The acetate form is an ester, which has a much greater stability than unesterified tocopherols. One of the principle differences between the dry and oil forms of this vitamin is that the former has no immediate antioxidant properties.

Solubility

It is insoluble in water, but soluble in ethanol, gasoline, ethyl and vegetable oil.
